

**NOTICE AND SERVICE REQUIREMENTS**

aka "*The Cheat Sheet*"

United States Bankruptcy Court, District of South Dakota

**Purpose.**

This chart is collated for the convenience of counsel from Title 11 of the U.S. Code (referenced by § signs), the Federal Rules of Civil Procedure (FRCP), the Federal Rules of Bankruptcy Procedure (FRBP), and the local rules of bankruptcy procedure (LBR) for the United States Bankruptcy Court for the District of South Dakota.\* Should any errors have been made, the information herein does not take precedence over the requirements set forth in the actual Code or rules.

**Use Tips.**

Where the "Whom to Serve" column states "mailing list," serve all creditors and other parties in interest in the main bankruptcy case. The list may be found on CM/ECF by selecting "Reports" for that particular case, then "Mailings," and then "Mailing Labels by Case." Where it states serve "parties in interest," serve the parties as set forth in Bankr. D.S.D. R. 9001-1(7). For either type of service, serve only those parties who are not electronically served.

**Search Feature.**

The Adobe toolbar contains a "Find" text box, which can be used to search for text. To use this feature, type a word, such as "compensation," in the "Find" text box and press "Enter." This will take you to the first entry in which the word "compensation" appears. Pressing "Enter" again will take you to the next entry in which "compensation" appears, and so on.
