## **Proposed Amendments to Local Bankruptcy Rules and Appendices**

In response to the Small Business Reorganization Act of 2019 ("SBRA") and some recent amendments to the Federal Rules of Bankruptcy Procedure and to address some other issues, the Local Bankruptcy Rules Committee has proposed amendments to a number of local bankruptcy rules and appendices. Below are links to the proposed amendments and three background documents: the SBRA, the proposed interim amended federal bankruptcy rules related to SBRA, and the amended federal bankruptcy rules that took effect on December 1, 2019.
