In recognition of and compliance with the findings and conclusions entered on the record June 16, 2016 and the Court's exhibits summarizing its analysis of certain services for which compensation is sought and its analysis of certain expenses for which reimbursement is sought, which exhibits were referenced by the Court on the record and are attached hereto; and for cause shown; now, therefore,

IT IS HEREBY ORDERED Debtors' Motion for Contempt (doc. 31) is granted as provided on the record, and First State Bank of Roscoe and John R. Beyers are each found in contempt of this Court's order discharging Debtors (doc. 16).

IT IS FURTHER ORDERED Debtors are awarded, as compensatory damages, \$159,605.77 for attorneys fees, comprising \$128,214.50 for compensation for services, \$8,333.94 for sales tax, \$14,785.37 for interest, and \$8,271.96 for reimbursement of expenses. First State Bank of Roscoe and John R. Beyers shall be jointly and severally liable for this sum.

IT IS FURTHER ORDERED Debtors are awarded \$50,000.00 for punitive damages. First State Bank of Roscoe and John R. Beyers shall each be individually liable for \$25,000.00 of this sum.
